- of the proper indicators to fix the objective value and to enable to measure its attainment at the time established for its execution.


The Quality/Environment System is realized in accordance with the requirements of the ISO 9001:2008 and 14001:2004 regulations and is involving all the business activities. To assure the realization of the Quality/Environment policy, the Directors authorize and delegate the Quality/Environment Responsible Person to handle the Management System in order to implement it, to coordinate the relevant application and constantly adjust it to the business necessities, to the regulations and to the evolution of the technology.

As a consequence of this, he has got the authority and the responsibility to perform inspections, audits and verifications, following the Company Manual and Procedures. The Quality / Environment Responsible Person is authorized to suspend every activity that jeopardizes the correct application of the Quality/Environment management system and is responsible to report to the Directors on the progress of the System.

Both Companies require to the whole personnel to operate in accordance with the Company established Quality / Environmental Politics, as described in the relevant Manual (describing the general lines of the System) and in the Procedures. Only through the involvement of all, an effective management of the Quality / Environment Management System will be possible, therefore the execution of the Quality / Environment Policy is required at any level of the organization, specifically on the base of the objectives assigned to everybody following the re-examination of the Management System for the Quality / Environment.

The whole personnel will be informed of the results achieved, and of the effectiveness of the System of the Quality / Environment System, at least once a year following the re-examination of the System itself.

Any doubt must be solved turning to the Responsible for Quality / Environment.
